Sir/Madam,

I am to convey the decision of the 100th Academic Council vide Resolution No:AC:100:2018:5:7:(i) held on 1st and 15th June 2018 which resolved grant of renewal of Provisional Affiliation for B.Ed. course 2(two) year for a period of 2(two) years w.e.f. academic sessions 2018-19 to 2019-20 in continuation to the Affiliation granted vide this office letter No.CDC/A.256/2012/-3645 dated 23/6/2015.

The College is required to fulfill the following conditions as laid down by the Inspection Team:-

1. Infrastructure:

The Institute will have to follow up with the CPWD, Shillong for handing over the building for enhancement of the space for laboratory, Arts and Craft Resource Room, Common Room, Common room for boys and girls. Further, the Institute is requested to make lift facility functional at the earliest.

b) Equipments for Experiments and Tests materials should be enhanced in Psychological

Laboratory.

c) The Water source of the Institute should be improved. This may be taken up on priority basis.

d) Generator Back up may be improved for continuous supply of power in the Institute.

e) Basic Medical Facilities may be thought of for the welfare of the students-teachers and the teaching and non-teaching staff.

2. Library:

a) The College needs to equip the Library with more copies of books relevant for all subjects.

b) The Library Automation should be made functional as early as possible.

c) The Institution may increase the library space for placing the shelves to allow easy access to the books on the shelves.

3. Appointment:

a) Appointment of required number of faculty members should be done according to the NCTE norms as per the Regulation 2014 and in accordance with the University Ordinance within a period of one year.

b) Regular faculty members with B.Ed degree should be encouraged to register for

M.Ed/M.A. Education through distance mode.

The fulfillment of the above conditions may be intimated to the undersigned at the earliest.

You are required to apply for renewal of Provisional Affiliation six months before the expiry of the affiliation period i.e. by January, 2020.
