
**Auction Sale Notice**

**Subject: Auction Sale for Disposal of Wooden Logs & full grown trees (Pine) on "as is where is basis" at NERIE, Umiam (Under Construction) site.**

It is hereby notified for public information that the Auction Sale for disposal of approx. 15 nos. of wooden logs and 6 nos. full grown trees (Pine) will be held on 25/05/2017 from 12.00 AM onwards on "as is where is basis" at NERIE Campus, Umiam. Interested individuals/parties may attend the auction.

2. The party quoting the highest rate shall be awarded the auction sale. An amount of Rs.2000/- (Rupees Two Thousand only) towards performance security will have to be deposited in cash by the party which has been awarded the auction sale.
3. The successful bidder shall have to deposit the full auctioned value plus applicable taxes, if any, on the auctioned value within two days (Excluding holiday of Bank) and the money shall be deposited in the form of demand draft from any Nationalised Bank drawn in favour of Principal, NERIE, Umiam.
4. If successful bidder fails to deposit money as mentioned above, performance security will be forfeited and option will be awarded to the next higher bidder or so on at the discretion of NERIE. In such case, the next higher bidder shall also have to deposit Rs.2000/- towards performance security.
5. Acceptance of the auction amount will be provisional subject to the approval of the competent authority of the NERIE, Umiam.
6. The reserve price of the wooden logs & trees is Rs.5,000/- (Rupees five thousand only).
7. Successful bidder should remove all the wooden logs from the site within 7 (seven) days from the date of acceptance of award letter.
8. The intending bidder must visit to satisfy him/herself regarding locations, size/girth and type of logs before participating in the auction (Contact Person: Mr. Dipak Dey, LDC).
9. Carriage of trees/logs shall not be carried out after the sun set and before the sun rise and permission, if any, would be arranged by the bidder him/herself.

10. **The bidding form will be provided on the date of bidding itself which has to be filled up by the bidder. The bidders are advised to carry with them a photocopy of Identity Proof (PAN Card/Voter Card/Adhar Card/Ration Card/Driving Licence) to be submitted along with the bidding proforma.**
11. A person or persons found indulging in or supporting willingly or unwillingly malafide intension at the time of auction and creating circumstances not congenial to hold auction peacefully shall be expelled at the discretion of NERIE.
12. NERIE reserves the right to accept or terminate the bidding process at any time without assigning any reason thereof.
13. Bidder has to arrange all necessary permit for transporting the logs at his own cost including payment of octroi, fee, taxes other charges etc. if any, as applicable.
14. Any damage or loss caused to NERIE property or disturbances of traffic rules during execution of work or permission from the respective agencies will have to be borne by the bidder.
15. Breach of any of the above conditions will render bidder liable to termination with or without notice and performance guarantee will be forfeited.
