Applications on prescribed format are invited from citizens of India for filling up one post of **Senior Accountant on deputation basis** in the Pay Band Rs. 9300-34800/- + Grade Pay Rs.4200/- (Group-B, Non-Gazetted, Ministerial) in the North East Regional Institute of Education - NCERT, Umiam, Meghalaya:

Eligibility Condition: By deputation from among the following:

- A. Officials holding same/analogous posts in various ministries/departments of Central / State Govt. on regular basis,
- OR**
- B. Junior Accountants/Accountants in the Pay Band of Rs. 9300-34800/- + Grade Pay Rs.4200 (Pre-revised Rs.5000-150-8000/-) who have rendered not less than three years of regular service in the grade.
- OR**
- C. Officials with 6 years' regular service in posts in the Pay Band of Rs. 5200-20200/- + GP Rs. 2800/- (pre-revised Rs. 4500-7000/-) or equivalent, with procedural knowledge of Central Government accounts,
- OR**
- D. Officials with 8 years' regular service in the posts in the Pay Band of Rs. 5200-20200/- + GP Rs. 2400/- (pre-revised Rs. 4000-6000/-) or equivalent, with procedural knowledge of Central Government accounts.

Note: The department officials in the feeder category who are in the direct line of promotion will not be eligible for consideration for appointment on deputation. Similarly deputationists will not be eligible for consideration for appointment by promotion. Period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or other organization/department of the Central Government shall ordinarily not exceed 3 years.

INSTRUCTIONS AND ADDITIONAL INFORMATION:-

1. The format of application is appended as Annexure 'A'. The applications from the willing and eligible officials whose services can be spared may be sent along with attested copy of ACRs/APAs for the last 5 years, integrity certificate and vigilance clearance so as to reach the undersigned on or before **23.05.2013**. Belated /incomplete applications will be rejected.
2. The deputation is initially for a period of two years or till the regular arrangement is made.
3. Maximum age limit for appointment by deputation shall not exceed 56 years as on the closing date of receipt of applications.

4. Deputation Duty Allowance will be allowed as per rules.
5. Incomplete/unsigned applications received without photographs, required certificates such as educational qualification, caste/community etc. duly attested by a Gazetted Officer and those received after the prescribed last date for receipt of application will summarily be rejected without any communication to the candidate.
6. Wrong declaration/submission of false information or any other action contrary to law shall lead to cancellation of the candidature at any stage.
7. No interim correspondence will be entertained.
