## NCERT'S Scholarship

- (i) All the Scheduled Caste and Scheduled Tribe Students admitted to the Course will be awarded scholarship of Rs.800/- per month. However, they should not avail other scholarships from their respective State Governments or from the Minority Welfare Scholarship-Merit Cum means Scholarship or the Post Metric Scholarship.
- (ii) Full relaxation of tuition fee for all the SC/ST students (for all four semesters), but other fees will have to be paid.
- (iii) Of the remaining students, up to 50% will be awarded the Merit cum Means Scholarship (Rs.800/- per month) as per rules. Full amount of this scholarship of Rs.800/- will be given to those students whose annual family income is Rs.2.5 lakh and below. Students whose annual family income is above Rs.2.5 lakh will be paid half scholarship i.e. Rs.400/- per month).

However, 27% of seats of OBCs, 5% of the students of general category including physically handicapped will be reserved for this scholarship.

- (iv) 20% of the remaining students will be awarded free- ship as per rules

### Kindly note that:

- a. Scholarship will be awarded only to those students who reside in NERIE Hostel
- b. Recent family annual income certificate is to be produced at the time of admission.
