Dear Sir,

As you may be aware, India has the highest rate of suicides in the world amongst students simply due to the unbearable pressure of exams. Students in schools experience high stress during examination, especially during their Board examination due to various reasons such as lack of preparation, style of their study, lack of needed information and pressure from parents and peers etc. The incidents of suicides due to exam anxiety are also being reported in the media from time to time.

Considering the seriousness of the nature of such incidents, Commission is launching a month long campaign #ParikshaParv during the exam period i.e. from 19<sup>th</sup> February- 15<sup>th</sup> March, 2019. This is intended to change the outlook/perspective of children towards exams. Even Hon'ble Prime Minister of India, Shri Narendra Modi, in Mann ki Baat, highlighted that "परीक्षा एक उत्सव है परीक्षा को ऐसे लीजिये जैसे मानो एक त्यौहार है।"

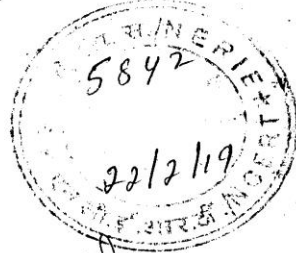
The campaign will entail Live streaming of Q&A sessions with renowned experts, psychologists; counsellors through Facebook/Twitter/Youtube to enable students interact with experts to reduce their exam stress. It will also include Radio spots/jingles and social media campaign for creating awareness and wider reach.
